- Closing date for receiving of application will be **21 days** from the date of first appearance of the Advertisement in the Employment News.
- If the closing date falls on a Holiday for the Factory, then the next working day shall be considered as the closing date for all purposes.

- (7) **General/ Conditions & other information to the candidates:**

- The self attested copies of educational qualifications, certificate for age proof, experience certificate from institutions etc., should be enclosed along with the application.

(8) Criteria for Engagement: -

- i. Engagement shall be for a period ranging from one to four years as mentioned above in Para (1). The tenure will come to an end automatically on completion of four years period from the date of joining, without any further notice. The employment can be terminated, at any time, during the period of tenure engagement, by giving one month's notice by either party or payment of the Basic Pay + IDA component in lieu of the Notice. There will not be any commitment to the candidate either for absorption as permanent employee or extension of term.
- ii. - iv. The performance of the individual on fixed term employment will be evaluated. Individuals having performance rating poor or below will be given One month's time in writing to improve their performance. After one month's again performance will be evaluated and if again the performance rating found poor or below, the services of the individual will be terminated by given 15 days notice.
- v. Personnel engaged will be eligible for EPF and employee Compensation act as per government guidelines.

- iii. These personnel will not be entitled for any other medical benefits in any of the Ordnance Factory Hospitals & Dispensaries or elsewhere. In case of an emergency, facilities in Ordnance Factory Hospitals/Dispensaries can be availed.
- iv. They will be entitled for safety and protective gears, equipment, kits etc. as per the Company norms.
- v. Female Personnel will be entitled to Maternity Benefits as per the provisions under the Maternity Benefit Act, 1961.
- vi. In the normal course, the engagement will be for a **maximum period of four years** from the date of engagement and the tenure will come to an end automatically on completion of four years period from the date of joining, without any further notice.
