Annexure –A Information for Submitting EOI by Interested Parties

1. Introduction:

- 1.1 Ordnance Factory, Badmal (OFBL) is under Munitions India Limited (MIL), Pune, Ministry of Defence, Govt. of India.
- 1.2 OFBL intends to replace its existing Hot Water Plants (3 nos.) with new, modern system to enhance operational performance.

2. The details of the existing Plants are as below:

The existing hot water plants supply hot water to three different jacketed vessels & 10 nos. of probe unit with desired temperature. The buffer tanks of the plants are of 1000 liters' capacity each. The plant is designed to keep the circulated hot water in liquid state even beyond 100°C.

- 2.1 Plant no.-1 For supply of Hot water to two Melters (temp.- 107°±8°C) having pipeline length of 80-100 meters and height 40 feet from ground.
- 2.2 Plant no.-2 For supply of Hot water to two Melters and Holding Vessel and Pour unit (temp.-90°±8°C) having pipeline length of 80-100 meters and height 40 feet from the ground.
- 2.3 Plant no.-3 For supply of Hot water to Probe unit (10 nos.) (temp. 90°±8°C) having pipeline length 50-60 meters on ground floor.

3. Scope of Work:

- 3.1 To dismantle, design, manufacture, supply, erection and commissioning of Hot Water Plants (3 nos.) to replace the existing plants. It is to note that in the proposed hot water plants, the buffer tanks (3 nos.) should be of 50 litters or less.
- 3.2 The Purchaser will arrange utilities like steam, water & electricity at the battery limits of the earmarked sites.
 - a. Detailed specifications with description of plant manufacturing process and lists of equipments required for each plant will be furnished in the tender documents which will be issued in Stage-2.
 - b. The plants should be operated and controlled with programmable logic (PLC) housed in a safe location indicated in the specification. It shall have appropriate automation for safety of workmen. There should be in-built safety and fire fighting devices as per Indian regulations.

4. Bidder's Profile & Qualification Criteria for Stage-1:

4.1 The interested parties (Bidders) must have the following qualification criteria for selection for Stage-2 (issue of tender documents):

a. Financial Criteria:

Bidder must have average annual turnover of minimum Rs. 1 crores in last three years.

b. **Technical Criteria**:

Bidder should have past experience of design, supply, erection and commissioning of the required plant or similar plants for chemicals/explosives either in India or in any other country.

- 4.2 The applications (EOI) of firms should be accompanied by following documentary evidence in support of meeting the above criteria / profile:

1. **Introduction:**

- 1.1 Ordnance Factory, Badmal (OFBL) is under Munitions of India Limited (MIL) Pune, Ministry of Defence, Govt. of India.
- 1.2 OFBL intends to do automation in the existing explosive (RDX/TNT) melter for automatic filling of explosive in moulds/mine bodies.

2. Scope of Work in brief:

- 2.1 A detachable header / attachment will be connected to the outlet pipeline from the Melter to a Header. The header/attachment will be designed to maintain the temperature upto 90° 95°C by circulating steam inside the header so that the explosive does not solidifies during the filling process.
- 2.2 The molten explosives will be poured/filled in the moulds by gravity. The moulds will be placed on a carrier which contains 16 nos. of moulds with funnels. The system will be provided with auto cut-off of flow of explosives after completion of the pouring up to the desired level in the moulds.
- 2.3 One trolley with lifting mechanism will be provided in front of the attachment/Melter on which the carrier with 16 pellets will be placed. The trolley with carrier will be taken to the Header machine with suitable mechanism and after reaching below the Header it will be lifted upto the desired height to facilitate pouring of the Melt.
- 2.4 All the accessories/equipment's must be flameproof.
- 2.5 The attachments should be operated and controlled with programmable logic (PLC) housed in the existing melter. It shall have appropriate automation for safety of workmen. There should be in-built safety and firefighting devices as per Indian regulations.
