**Procedure to register a Complaint under the Sexual Harassment of Women at
Workplace (Prevention, Prohibition and Redressal) Act 2013**

Internal Complaints Committee (ICC) as per the provisions of the Section 4 of "The Sexual Harassment of Women Employees at Workplace (Prevention Prohibition and Redressal) Act, 2013 has been constituted at Munition India Limited (MIL), Pune, Head Office. Unit level ICC(s) are already in place under respective units under Munitions India Limited.

Any aggrieved women employee who wishes to lodge a formal complaint may do so by approaching the respective ICCs (Internal Complaints Committee) at the unit / factory or at MIL Head Office.

Alternately, a formal complaint may be lodged with the ICC at MIL Head Office through mail at the individual mail IDs as detailed below. However, complaints made to ICC at MIL Head Office, which are not specific to MILHQ employees, will be redirected to the concerned Unit / factory ICC for dealing with the matter in accordance to the provisions as stipulated under the said Act.
